All requests for bid clarification must be submitted in writing to the Buyer referenced above and received no later noon (12:00 PM Eastern Time) on **February 24, 2025.**

All questions will be answered and documented in writing as an Addendum to the Bid. These will be sent out to all Bidders who received the original Bid no later than **February 26, 2025.**

**DUPLICATE COPIES:**

**Please submit your bid in duplicate; the original and one (1) copy.**

**BID INFORMATION:**

At the time of bid, the bidder shall supply detailed specifications covering the item(s) contained herein, and shall clearly indicate any areas in which item or items offered do not fully comply with the specifications contained herein.

**SUBMITTAL OF  
FORMAL PROPOSAL:**

Bid proposal must be legible and submitted in the original form, bearing an original signature. **EMAILS AND FACSIMILES ARE NOT ACCEPTABLE.**

**All bidders must submit proof that they have obtained the required Workers' Compensation and Disability Benefits Insurance coverage or PROOF that they are exempt. (Visit [www.wcb.ny.gov](http://www.wcb.ny.gov) for forms.)**

**WAGE RATES:**

Contractor agrees to comply with the provisions of the New York State Labor Law relating to the payment of prevailing wage rates to the extent that such rules may be applicable to the Contractor. Wage rates may be obtained at [www.labor.state.ny.us](http://www.labor.state.ny.us)

**SPECIFICATION  
ALTERATIONS:**

Specifications will be construed to be complete and be considered the entire description of the goods or services upon which Monroe County is now seeking bids. **Only formal written addenda can materially alter this set of specifications.** No verbal statement made by a Monroe County employee or anyone else is binding nor shall such statement be considered an official part of this public bid proposal.

**QUANTITIES:**

The quantities listed are the estimated annual requirements and should not be construed to represent either maximum or minimum quantities to be ordered during the contract term.

**BRAND REFERENCE:**

References to a manufacturer's product by brand name or number are done solely to establish the minimum quality and performance characteristics required. Bidders may submit bids on alternates, but must attach two (2) copies of manufacturer specifications for any alternate at the time of the bid. Further, the bidder must demonstrate that the alternate proposed has a sufficient operating track record to show the equipment will perform per the specified brand. The acceptance of a bidder's alternate rests solely with Monroe County.

**QUALIFIED BIDDER:**

Each bidder must be prepared to present satisfactory proof of his capacity and ability to perform this contract. Such proof may include, but is not limited to, an inspection of the bidder's facilities and equipment, financial statements, references and performance of similar contracts. **The Purchasing Manager reserves the right to reject any bid where the bidder cannot satisfy the County as to his ability to perform.** Monroe County reserves the right to reject any and all bids if the Monroe County Purchasing Manager deems said action to be in the best interests of Monroe County.

**METHOD OF AWARD:**

Monroe County intends to award one or more contract(s) to the lowest responsive and responsible bidder(s). The County reserves the right to award the bid as a **whole or by Group or item, depending on whichever method results in the lowest overall cost to the County. Separate awards will be considered only when the price offered is great enough to offset the additional costs inherent to multiple contracts.** Bidders are not required to bid on every Group included in the bid; however, they must bid on every item within each Group in order to be considered. **The County reserves the right to reject any and all bids** if the Purchasing Manager deems said action to be in the best interest of the County.

**CONTRACT TERM:**

Contract will start with the date of the contract award and run through **January 31, 2026**, with the option to renew the contract up to four (4) additional twelve (12) month periods at the mutual consent of both parties.

**PRICE CHANGES:**

Price changes may be proposed by either party no later than forty-five (45) days prior to contract extension, based upon manufacturer price changes which must be supported with documentation. Should price changes not be acceptable to both parties, the contract will not be extended. Prices may change only at the time of extension.

**MINIMUM ORDER:**

No minimum order is specified for this contract. Agencies must be able to order as needed.

**DELIVERY:**

All deliveries to be F.O.B. Monroe County to agency as specified by a Purchase Order. Delivery costs must be built into the unit prices bid. Deliveries must be made within two (2) days after receipt of purchase order number. The County reserves the right to terminate the contract in the event the specified delivery time is not met.

**PURCHASE ORDER**

Delivery of services may be directed by the receipt of a Purchase Order only.

**ISSUANCE:**

Items that are not part of this bid will not be paid for by Monroe County. As to all purchase orders issued by Monroe County, exceptions may only be authorized, in writing, by the Purchasing Manager or her authorized agent prior to delivery.

**BILLING  
PROCEDURE:**

All invoices for items sold any authorized agency as a result of this contract must be billed in the following manner: Purchase Order #, Quantity, Description of Item Purchased, BP#, Item #, Extension and Total. **ALL INVOICES MUST BE MARKED WITH THE PURCHASE ORDER NUMBER. INVOICES WITHOUT THIS INFORMATION WILL NOT BE PROCESSED FOR PAYMENT.**

**WARRANTY/  
GUARAGUARANTEE:**

All warranties by manufacturer shall apply. Bidder shall, as part of its proposal, furnish its warranty/guarantee for all goods/services to be furnished hereunder. As a minimum, Bidder shall warrant all goods for a period of one year from date of acceptance. Bidder shall be obligated to repair or replace all defects in material or workmanship which are discovered or exist during said period. All labor, parts and transportation shall be at Bidder's expense.

**UNCONTEMPLATED  
PURCHASES:**

Monroe County reserves the right to request separate bids for such quantities of items on this contract that may be best procured via separate public bid offering and to otherwise act in furthering its own best interests.

**SUBCONTRACT:**

The Contractor shall not subcontract any work without first obtaining the written consent of the Monroe County Purchasing Manager.

**RELATED ITEMS:**

The County reserves the right to add miscellaneous related items to this contract during the contract term upon agreement by both parties as to the price. Approval must be given in writing by the Purchasing Manager or her Designee.

**REPORT OF  
PURCHASE:**

The Contractor must, upon request, provide the County Purchasing Manager with detailed information showing how much of each item was delivered, to any and all agencies under this contract. This includes deliveries to not only the County but any other municipality or agency which orders from this contract.

**SECURITIES AND  
INSURANCE:**

Any Certificate of Insurance, Bonds or other forms of security required by this bid are to be submitted to the Purchasing Manager no later than ten (10) normal business days following the date of notification of award. Documents must be received by the close of business, 5:00 P.M. on that day.

**COMPLIANCE WITH  
THE LAW:**

The Contractor agrees to procure all necessary licenses and permits. The Contractor shall comply with all laws, rules, and regulations pertaining to the payment of wages and all other matters applicable to the work performed under this contract.

**INDEMNIFICATION:**

The Contractor agrees to defend, indemnify and save harmless the County, its officers, agents, servants and employees from and against any and all liability, damages, costs or expenses, causes of action, suits, judgments, losses and claims of every name not described, including attorneys' fees and disbursements, brought against the County which may arise, be sustained or

occasioned directly or indirectly by any person, firm or corporation arising out of or resulting from the performance of the services by the Contractor, arising from any act, omission or negligence of the Contractor, its agents and employees or arising from any breach or default by the Contractor under this Agreement. Nothing herein is intended to relieve the County from its own negligence or misfeasance or to assume any such liability for the County by the Contractor.

**EQUAL PAY  
CERTIFICATION:**

Prior to the execution of this Agreement, the Contractor shall submit to the County an Equal Pay Certification ("Certification") affirming the Contractor's compliance with the Federal Equal Pay Act, 29 USC § 206 and New York State Labor Law §194, as amended from time to time ("Equal Pay Laws"). As set forth in the Certification, the Contractor's violation of one or more of the Equal Pay Laws or its filing of a false or misleading Certification during the term of this Agreement may constitute grounds for the County in its sole discretion to immediately terminate the Agreement and for determining the Contractor to be not qualified to participate in future Monroe County contracts.

**SPECIFICATIONS**

**1.00 GENERAL**

**1.01 SCOPE:**

The County of Monroe is seeking a qualified bidder(s) to furnish various pieces of small to medium equipment on a rental basis. The following outline is intended to generally describe and specify the equipment rental service. The contract resulting from this bid will be available to all Monroe County departments and political subdivisions. However, it is anticipated that the Division of Pure Waters will request the majority of the rentals.

**1.02 LOCATION:**

Any specified location within Monroe County.

**1.04 QUALIFICATIONS OF EQUIPMENT RENTAL COMPANY:**

Consideration will be given only to equipment of rental companies who can demonstrate that their product complies with the specifications. The technical information submitted by the bidder must address how the proposed equipment meets these specifications. Consideration will be given only to vendors who can demonstrate that their equipment, background and technical abilities comply with the specifications. The County shall have the sole responsibility for determining from the information submitted by the low bidder if the proposed equipment meets the specifications. Should the apparent low bidder fail to meet the requirements of the specifications as determined by the County's review, the bid shall be rejected and the next low bidder shall be considered. The County may require additional supplementary information during the review process. The bidder's technical specifications must provide sufficient detail to permit an evaluation of the proposed equipment but shall not be considered as satisfying the requirements for the submission of manuals.

**1.05 BIDDER REQUIREMENTS:**

The bidder shall have the capability of providing equipment for rental after normal business hours in response to the County's emergency needs. **Each bidder must supply with their bid contact names and phone numbers to cover this requirement.**

**2.00 TECHNICAL SPECIFICATIONS:**

**2.01 RENTAL RATES:**

It is understood and agreed upon that the rental rates specified on the unit price sheet are based upon defined hours of the County's right to possession of and maximum use of the equipment rented. Hours are defined on the following rental bases as follows:

- a. Daily Basis - Any use up to a total of eight (8) hours. Additional hours will be pro-rated according to eight (8) hour days.
- b. 5-Day Weekly Basis - Any use up to a total of five (5) days, eight (8) hours per day. Additional hours will be pro-rated according to five (5) day weeks.
- c. 20-Day Monthly Basis - Any use up to a total of twenty (20) days, eight (8) hours per day. Additional hours will be pro-rated according to twenty (20) days/month.

## **2.02 RENTAL PERIOD:**

The rental period shall begin on the date and time of acceptance of the equipment by the County and shall end at the time and date of the County's verbal notification to the bidder that the equipment is no longer needed. If the bidder chooses to delay picking up the equipment, thereby leaving it on the County's property, an additional day or more beyond the daily, weekly or monthly rental period, they may do so as long as this is mutually agreeable between the two parties. **However, there will be no additional charge for the equipment to the County once the bidder is notified that the equipment is no longer needed.**

## **3.00 EQUIPMENT:**

### **3.01 CARE:**

The bidder shall use reasonable care to see that the equipment is in proper working condition before shipment to the County. It is not to be actually operated or tested unless such operation or test is deemed necessary by the bidder or unless the County shall request such operation or test results in writing. In the event of notice to the bidder by the County that the equipment is not in good, safe and serviceable condition and fit for use upon its arrival, the bidder shall have the obligation to put the equipment in good, safe and serviceable condition within a reasonable length of time. If this cannot be done by the time use of the equipment is required by the County, then the bidder will provide a different but similar piece of equipment to the County for its use.

### **3.02 MAINTENANCE:**

The bidder agrees to maintain the specified equipment in good operating condition throughout the term of the rental agreement and shall perform such maintenance and repair in accordance with the manufacturer's instruction. The bidder further agrees it will perform such maintenance including fuel (if the equipment is operator equipped), lubrication and the installation of replacement parts and components, as the County may deem necessary for the preservation of such equipment. **The County will not be responsible for any rental charges while the equipment is down and not operating due to maintenance by the bidder.**

### **3.03 RESPONSIBILITY:**

The bidder must accept full and complete responsibility for providing equipment that is in excellent operating condition, capable of performing and adequate to perform the tasks identified by the County. The County will not accept responsibility for any equipment or other damage or failure caused by the bidder's failure to provide equipment or operators capable of performing the tasks

specified. Although the County will provide general supervision, the County will not be responsible or liable for operator negligence. In addition, the bidder agrees to defend, hold harmless and indemnify the County from and against any or all claims arising out of the acts or negligence of the bidder, its agents or employees.

**3.04 DELIVERY:**

All equipment must be delivered to the Monroe County work site (as specified by the ordering agency) within four (4) hours of the verbal request of the County. No additional delivery/travel charges will be allowed. The bidder's personnel are responsible for unloading (from the bidder's vehicle) the equipment upon the County's work site. The bidder is also responsible for reloading the equipment returned by the County. Rental requests must be honored 24 hours/day, 7 days/week.

**3.05 OPERATORS:**

Prices bid are for equipment without operators (unless otherwise noted on the unit price sheet). Should the County require an operator, the bidder must provide the operator within the delivery time frame specified and must pay applicable New York State prevailing wage rates at a minimum.

**3.06 FUEL:**

The bidder will deliver all fuel operated equipment with a full tank of fuel. The County will assume responsibility for all refueling costs of the equipment during the rental period.

**4.00 ITEMS:**

**4.01 TYPICAL ITEM EXAMPLES:**

Bidder must be able to provide all of, but are not limited to, the following types of equipment:

- a) Air compressors, tools and accessories
- b) Rollers and compaction equipment
- c) Concrete and masonry equipment
