CONTRACT TERM:	Contract will start with the date of the contract award and run through September 30, 2020, with the option to renew the contract up to four (4) additional one (1) year periods with the mutual consent of both parties.
PRICE CHANGES:	Price changes may be proposed by either party no later than forty-five (45) days prior to contract extension, based upon manufacturer price changes which must be supported with documentation. Should price changes not be acceptable to both parties, the contract will not be extended. Prices may change only at the time of extension.
MINIMUM ORDER:	No minimum order is specified for this contract. Agencies must be able to order as needed. <b>Political subdivisions and others authorized by law may</b>
	participate in this contract.
<u>DELIVERY:</u>	All deliveries to be F.O.B. Monroe County to agency as specified by a Purchase Order. Delivery costs must be built into the unit prices bid.
